AUCTION RULES AND PICK-UP INSTRUCTIONS

All sales are final. There will be no exchange, refunds, or substitutions. Items will be available for pick up at the Guardian ad Litem Program Office in downtown Fort Lauderdale, 612 S Andrews Avenue, Suite 1000, Fort Lauderdale, FL 33301, on **February 8, 2021 between 5:15 - 6:00 pm.**

GENERAL: All items are sold "as is". No returns will be accepted and no refunds permitted. The law of the State of Florida shall govern with respect to all auction sales. Once a bid is placed, it cannot be retracted. Please make sure you are aware that ALL bids are final and cannot be removed. The winner WILL be responsible for ALL shipping costs to be charged at the time of close-out. Any individual bidding on alcohol items represents that he/she is acting in compliance with all federal, state, and local laws regarding the purchase, transportation, and delivery of alcohol, and Winner is solely responsible for payment of any applicable fees or taxes, including state or federal excise or use taxes.

SHIPMENT: Items will only be shipped to Winners that live outside Broward County. All Winners that live in Broward County must pick up items at the above designated date, time, and location. Winners that live outside Broward County authorize Voices for Children of Broward County to act on its behalf to engage UPSP or FedEx to deliver Winner's order to its selected destination. Winner is responsible and liable for ensuring the accuracy of his/her shipping address. Please email Erica info@voicesbroward.org within 24 hours of the close of Auction with the address you'd like your winning item(s) shipped to if it is not the address that you used to sign up for the Auction. Your item will be shipped as soon as payments have been processed.

TRAVEL PACKAGES: It is the buyer's responsibility to make his or her own travel reservations. It is strongly suggested that you plan your travel three to four months ahead of time. Taxes on Travel Lots are the responsibility of the winning bidder. Only those services listed in the lot description are included. Some restrictions may apply, and there may be some travel blackout dates. Lost or stolen travel vouchers cannot be replaced. Winner is responsible for shipping charges.

RESTAURANT/HOTEL PACKAGES/CERTIFICATES: If the item purchased is a casualty of the economy (i.e. business goes out-of-business) it is not the responsibility of Voices for Children of Broward County to replace the item or refund the money.

PAYMENT: Each buyer must pay the full purchase price of each Lot purchased, at the close of the auction. Winners with declined cards will have 2 business days to provide an alternate form of payment- after that time, auction lots will be offered to the next highest bidder.

AGE REQUIREMENT: Alcohol purchasers must be 21 or over. Voices for Children of Broward County makes every effort to ensure that alcohol is not delivered to any individual under the age of 21. Winner is responsible for ensuring that an individual over the age of 21 is present at the shipping address to receive and sign for the delivery and is not intoxicated at the time of delivery. Winner also agrees that any alcohol won from Voices for Children of Broward County's Auction is for personal consumption and not for resale.
