# Voices for Children of Broward County announces new center and kickoff of its Hearts of Hope: Building a Future Campaign

Today, Voices for Children of Broward County (Voices) is excited to announce The Mimi Center of Hope as the new home for Voices and the kickoff for the Hearts of Hope: Building a Future Campaign.

Since 2011, Voices for Children of Broward County ("Voices") has served as the primary non-profit partner to the 17th Circuit Guardian ad Litem Program. Voices works to ensure that every child victim of abuse, neglect, and abandonment in Broward County has a court-appointed volunteer Guardian ad Litem and that services are available for each child's accompanying health, educational, and social needs. During the last 11 years, Voices has served more than 10,000 foster care children in our community.

While we are proud of the strides made on behalf of the foster care children we serve thus far, we recognize there is still much to be done. In reflection on the number of children served in recent years, watching current case trends, the uptick of child abuse, and the immense future growth in our community, additional children entering the foster care system are inevitable. "Meeting the needs of foster care kids in the South Florida in our current space has been an ever-increasing challenge", states President & CEO, Erica Herman. "Due to the physical capacity of the current space coupled with the consistent growth over the years, we have been in pursuit of a new location that can adequately serve us and pleased to announce The Mimi Center of Hope and the Hearts of Hope: Building a Future Campaign."

The Campaign hopes to raise \$25,000 to support the growing needs our community and efforts will focus on expanding physical capacity to increase services and support programs for foster care children, creating a space for growing partnerships and collaborations to provide higher quality programs and services for foster care children, and updating technology needs to better serve more complex cases, improve data collection, provide quality assurance, and demonstrate the impact we have on our community's most vulnerable youth.

The Campaign is structured so that the community can contribute through recognition and naming opportunities.
